ORDINANCE NO. 2012-7

**AN ORDINANCE AMENDING ORDINANCE NO. 2006-7 ESTABLISHING
RATES AND CHARGES FOR THE USE AND SERVICES RENDERED BY
THE WATERWORKS OF THE TOWN OF EDINBURGH**

I. SECTION 1. EXISTING ORDINANCES

- a. That the Edinburgh Town Council ("Council") adopted and Ordinance No. 2006-7, ("2006 Ordinance") which amended Ordinance No. 1997-6, that provided the water rates and charges for the use and services rendered by the waterworks of the Town.

II. SECTION 2. MODIFICATION TO RATES

- a. That Council finds that the rates and charges established by the 2006 Ordinance are insufficient to enable the Town to properly operate its waterworks plant, service its bonds, and finance additions and improvements to its waterworks system;

III. SECTION 3. REMAINDER OF RATE STUDY

- a. That all other provisions of the 2006 Ordinance, shall remain unaltered and in full effect.

IV. SECTION 4. ADOPT RATES WITH MODIFICATIONS

- a. That for clarity purposes, the Council desires to adopt new rates with the modifications contained in the 2006 Ordinance and the modifications provided herein. That the revised rates with the modifications contained in the 2006 Ordinance and the modifications provided herein is attached hereto and made apart hereof as Exhibit "A". ("Modified Rates")
- b. That the Council hereby adopts and approves the Modified Rates.

V. SECTION 4. PUBLIC BENEFIT

- a. That the Council finds that revising the rates as provided herein and adopting the Modified Rates will be in the best interest of the Town and for the benefit of the public and residence of the Town.

VI. SECTION 5. SEVERABILITY

- a. Should any section or provision of this Ordinance be declared by the Courts to be unconstitutional or invalid, such decision shall not affect the validity of the Ordinance as a whole, or any part thereof, other than the part declared to be unconstitutional or invalid.

- a. All ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.


VIII. SECTION 7. EFFECTIVE DATE


- a. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.


