

ORDINANCE NO. 2012-15

**AN ORDINANCE AMENDING CHAPTER 75 OF THE TOWN
OF EDINBURGH'S CODE REGARDING PARKING
ON WALNUT STREET**

WHEREAS, Indiana Code 36-1-3-6, gives the legislative body of the Town of Edinburgh ("Town") the power to regulate parking on the streets located within the Town;

WHEREAS, Francis Swift filed a petition with the Edinburgh Town Council requesting that the parking on Walnut Street located within the Town be changed;

WHEREAS, the Edinburgh Town Council conducted a public hearing on the 10th day of September, 2012 over Mr. Swift's petition and heard evidence to support and oppose the same;

WHEREAS, the Edinburgh Town Council approved Mr. Swift's petition at the meeting on the 10th day of September, 2012.

NOW, THEREFORE, BE IT ORDAINED BY THE EDINBURGH TOWN COUNCIL, AS FOLLOWS:

I. SECTION 1. AMENDMENTS TO CODE

a. That the Council hereby amends Chapter 75; of the Edinburgh Town Code ("Code") in its entirety and replace the same as follows:

i. The following language shall be added to Schedule II (E) shall be amended as follows:

1. *"Walnut Street . . . Both . . . Main Cross Street to ¼ block south of Main Cross . . . 2 hours on both sides of Walnut Street . . . At all times".*

ii. Schedule V (A) shall be amended as follows:

1. The row that states *"Walnut Street . . . Both . . . Main Cross Street to ¼ block south of Main Cross . . . At all times"* shall be deleted.

II. SECTION 2. PUBLIC BENEFIT

- a. That the Edinburgh Town Council finds that this Ordinance will be in the best interest of the Town and for the benefit of the public and residence of the Town.

III. SECTION 3. REPEALER

- a. All ordinances or parts of ordinances in conflict with provisions of this Ordinance are hereby repealed.

IV. SECTION 4. SEVERABILITY


- a. Should any section or provision of this Ordinance be declared by the Courts to be unconstitutional or invalid, such decision shall not affect the validity of the Ordinance as a whole, or any part thereof, other than the part declared to be unconstitutional or invalid.

V. SECTION 5. EFFECTIVE DATE


- a. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.






