Building & Improvement Permits

The following items are required by the Building & Zoning Official for plan review prior to the issuance of the permit:

- One set of construction documents, including foundation, floor(s), roof, plumbing, electrical, and mechanical plans, wall section(s), exterior elevations, details of stairs, engineered truss detail, and material list
- Site plan showing location of the proposed structure and/or improvements, existing structures, property lines, easements, and setbacks with distances between property lines and structures
- State Design Release for commercial work unless the scope of work is exempt from filing

Please contact our office for the specific items required for your project. The more information provided, the better we can assess your project for code compliance.

Edinburgh Zoning Ordinance 150.20 states: "A permit shall be obtained before beginning construction, alteration, or repair of any building or structure, the cost of which exceeds \$500, using forms furnished by the Building & Zoning Official, and all fees required by this code shall be paid to the Clerk-Treasurer."

Edinburgh Zoning Ordinance 156.005 states: "No structure shall be located, erected, constructed, reconstructed, moved, converted, or enlarged; nor shall any structure or land be used or be designed to be used, except in full compliance with all the provisions of this Article and after the lawful issuances of the permits required by this Article."

Edinburgh Zoning Ordinance 156.241 states: "No permit shall be issued unless the proposed structure or use of structure of land is in complete conformity with the provisions of this Article or unless a written order is received from the Board of Zoning Appeals, the Plan Commission, or court in accordance with this Article and State legislation. (1) An Improvement Location Permit shall be obtained before any structure may be constructed, reconstructed moved, enlarged, or structurally altered."

If you are thinking of making additions, improvements, or alterations to your home or residential property, a permit is required for most improvements, including but not limited to:

- New Residential Dwellings
- Temporary Modular Homes and Mobile Homes
- Sheds and Storage Buildings
- Attached or Detached Garages and Carports
- Swimming Pools (in ground and above ground)
- Permanent or Temporary Signs

- Room Additions and Sunrooms
- Elevated Decks and Porches
- Electrical Service upgrades
- Kitchen and Bath remodels
- Window Replacement
- Storage Tanks
- Demolition and House Moving

Some projects require approval of the Board of Zoning Appeals or Plan Commission. Please plan ahead as this process takes some time. Projects that require pre-approval are:

- Change of Use of a structure
- Home Occupation
- Encroachment into required yards
- Accessory Structures larger than 720
- Properties in the Highway Corridor District (SR 252 & US 31)

If you are thinking of making additions, improvements, or alterations to your commercial property or rental space, a State Construction Document Release and local permit are required for most construction projects, including but not limited to:

- New Commercial/Public Buildings
- Temporary Occupancy
- Alterations and Renovations

- Change in use or occupancy
- Changes effecting the Means of Egress
