

## RESOLUTION NO. 2020-14

### A RESOLUTION EXPANDING THE TIME PERIOD OF LIMITING ACCESS DUE TO COVID-19

WHEREAS, the Town of Edinburgh, by and through the Edinburgh Town Council (“Town”) passed Resolution 2020-7 that implemented certain measures to limit the exposure of the COVID-19 virus to the citizens of Edinburgh up and until April 13, 2020; (“Deadline”)

WHEREAS, the Town of Edinburgh, by and through the Edinburgh Town Council (“Town”) passed Resolution 2020-10 that extended the measures listed in Resolution 2020-7 regarding limiting the exposure of the COVID-19 virus to the citizens of Edinburgh up and until April 27, 2020; (“Extended Deadline”)

WHEREAS, the Town of Edinburgh, by and through the Edinburgh Town Council (“Town”) passed Resolution 2020-13 that extended the measures listed in Resolution 2020-10 regarding limiting the exposure of the COVID-19 virus to the citizens of Edinburgh up and until May 11, 2020; (“Second Extended Deadline”)

WHEREAS, the State of Indiana, by and through Governor Eric Holcomb, and taken measures to address the COVID-19 virus through certain Executive Orders and has extended the ending date of those orders; (collectively referred to as “Orders”)

WHEREAS, in concert with the Orders; the Town wants to extend the Extended Deadline;

**NOW, THEREFORE, BE IT RESOLVED**, by the Edinburgh Town Council that the following shall occur:

Effective Monday, March 16, 2020 to Tuesday, May 26, 2020:

- Town Hall
  - Access to the Town Hall will be restricted for emergency purposes only.
    - All citizens are encouraged to pay their utility bills online, with any processing fee being waived.
    - All citizens are encouraged to utilize the overnight drop-box at the Town Hall to submit their utility bill payments.
  - The Town Hall telephone number (812-526-3512) and utility office number (812-526-3514) will still be staffed and able to provide assistance to anyone in need or answer any questions.
- Edinburgh Parks and Recreation
  - All activities and access to Sports Complex will be suspended until May 26, 2020.
  - All baseball and softball games at the Edinburgh ball diamonds will be suspended until May 26, 2020.
  - All rentals of campsites will be cancelled up to May 26, 2020 with a full refund of any deposit made.
  - The BASE program will be suspended until May 26, 2020.
- John Drybread Community Center

- All activities and access to the Community Center will be suspended until May 26, 2020.
- Timbergate Golf Course
  - The Timbergate golf course will remain open but access to the club house will be limited; PRO-SHOP RETAIL WILL OPEN WITH A MAXIMUM CAPACITY OF 6 PRESENT IN SHOP AT ONE TIME.
- Waste Water Department
  - Access to the compactor will be AVAILABLE ON FRIDAY'S, 8:00 AM-4:00 PM
- Edinburgh Recycling Depot, located at 610 Mary Drybread Court will be OPENED ON May 26, 2020.

The Edinburgh Town Council will review and assess these actions taken at their meeting on May 26, 2020 to decide if such action shall be extended.
