

**ORDINANCE NO. 2023-16**

**AN ORDINANCE AMENDING CHAPTER 74 OF THE TOWN  
OF EDINBURGH'S CODE REGARDING STOP SIGN AND SPEED LIMIT  
SIGN ON EXPANSION OF MAIN STREET**

WHEREAS, Indiana Code 36-1-3-6, gives the legislative body of the Town of Edinburgh ("Town") the power to regulate parking on the streets located within the Town;

WHEREAS, the Edinburgh Town Council has expanded the existing public road called Main Street to the south from where it originally terminated at West Industrial Drive and expanded the same south to now terminate at West 900 North; ("Expansion")

WHEREAS, due to the Expansion, new traffic signs consisting of a stop sign and speed limit sign need to be added;

WHEREAS, the Edinburgh Town Council wishes to add the necessary traffic signs concerning the Expansion.

**NOW, THEREFORE, BE IT ORDAINED BY THE EDINBURGH TOWN COUNCIL, AS FOLLOWS:**

**I. SECTION 1. AMENDMENTS TO CODE**

a. That the Council hereby amends Chapter 74; of the Edinburgh Town Code ("Code") as follows:

i. The following language shall be added to Schedule I:

*"Street Name - Main Street (Northbound)*

*Location – County Road 900 North to West Industrial Drive*

*Maximum Speed – 40 mph*

*When Applicable – At all Times"*

ii. The following language shall be added to Schedule V:

1. *"Stop Street – Main Street*

2. *Cross Street – County Road 900 North"*

**II. SECTION 2. PUBLIC BENEFIT**

a. That the Edinburgh Town Council finds that this Ordinance will be in the best interest of the Town and for the benefit of the public and residence of the Town.

**III. SECTION 3. REPEALER**

- a. All ordinances or parts of ordinances in conflict with provisions of this Ordinance are hereby repealed.

**IV. SECTION 4. SEVERABILITY**


- a. Should any section or provision of this Ordinance be declared by the Courts to be unconstitutional or invalid, such decision shall not affect the validity of the Ordinance as a whole, or any part thereof, other than the part declared to be unconstitutional or invalid.


**V. SECTION 5. EFFECTIVE DATE**


- a. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.


